SUPPLEMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR THE SETTINGS OF LAKE RHODHISS

This Supplement to the Declaration of Covenants, Conditions and Restrictions for The Settings of Lake Rhodhiss is made this <u>q</u> day of March, 2007 by The Settings of Lake Rhodhiss, LLC, A Georgia Limited Liability company ("Declarant")

WITNESSETH

WHEREAS, Declarant, as the developer of The Settings of Lake Rhodhiss, recorded that certain Declaration of Covenants, Conditions, and Restrictions for The Settings of Lake Rhodhiss, on March 1, 2007 recorded in Deed Book 1644, Page 1, of the Burke County, NC Registry (as may be amended from time to time, the "Declaration"), and

WHEREAS, the original plat references for Phase 1 of the Settings of Lake Rhodhiss as provided in the original attached EXHIBIT A to the Declaration were incorrect, and

WHEREAS, pursuant to Article 16.2 of the Declaration, Declarant has the unilateral option, right and privilege to amend the Declaration for any purpose by filing in the public records, an amendment or Supplemental Declaration; and

WHEREAS, the Class "B" membership as set forth in Article 3 3 (b) of the Declaration has not been terminated, and

WHEREAS, any such amendment shall be effective upon the filing for record of any such amendment or Supplemental Declaration, unless otherwise provided therein, and

WHEREAS, Declarant wishes to exercise its unilateral option, right and privilege to amend

the EXHIBIT A to the Declaration, and

NOW THEREFORE, in consideration of \$10 00 and other valuable considerations the receipt and sufficiency of which is hereby acknowledged, the Declarant hereby amends the original EXHIBIT A to the Declaration as follows.

- The amended EXHIBIT A is attached to this Supplemental to the Declaration and is incorporated herein as if set forth verbatim
- Except as specifically modified hereinabove, the Declaration shall remain in full force and effect. The terms hereof shall be supplemental to the terms of the aforesaid Declaration and in the event of any inconsistency, the terms of the Declaration shall control. This Amendment shall be effective upon its filing for record in the Public Records of Burke County, North Carolina and shall be binding upon and inure to the benefit of all Owners of Lots in the Community and their respective heirs, executors, administrators, legal representatives, successors and assigns
